## MARKS BYLAWS ~

The revised Bylaws were sent to each member by email and are available on the MARKS RC website. Here are a few of the significant changes from the previous Bylaws:

- MARKS is no longer a corporation chartered by the State of Maryland.
- The MARKS fiscal year is April 1 to March 31.
- Membership runs April 1 until March 31.
- Existing members are required to submit a Membership Application and Renewal Form and pay the full dues in accord with the membership type on or before April 1 of the year in which they wish to be a member.
- Family Membership: To be eligible for a family membership, a person must reside in the same household as an individual member in good standing, must maintain an AMA membership, must maintain an FAA registration, may not offer motions or vote in business meetings, may participate in all MARKS social activities and events, and may upgrade to individual membership by paying the additional dues
- The secretary shall maintain records of the current members including but not limited to their name, physical address, email address, telephone number, AMA membership and FAA registration numbers if applicable to the member, and any other information obtained through the Application and Renewal Form.
- The secretary shall post a list of members authorized to fly at Waybright Field in a prominent place at the field. The list will be updated on the first day of each calendar month.
- The Board is now referred to as the Executive Committee.

A minimum of 5 members of the executive committee must be present, either in person or virtually, at the same time for the executive committee to conduct the business of MARKS.
