Watts per pound

When modifying a glow engine airplane to electric I didn't know a formula for the conversion. Here is one I found in Model Aviation Magazine. This categorization is a loose, flexible way to estimate the amount of power that you'll need for a specific-size airplane while giving the performance required for safe flight. This rule is really a guideline to determine how many watts of power are needed per pound of airplane weight and is expressed as W/lb. Here are some commonly accepted numbers. (fast fact: 746 watts= 1hp).

50W/lb or less - very lightweight micro RC and slow flyers

50-75W/lb -sport powered sailplanes and gliders, basic trainers, lightweight scale planes, vintage RC flyers, and RC assist-free flight designs.

75-100W/lb - basic sport flyers, intermediate aerobatics, scale low-wing designs, and medium-size warbirds

100-150W/lb - advanced aerobatics, pattern flying, 3D planes, larger warbirds, and jets
