MEMBER MEETING MINUTES ~

The meeting was called to order by President Wally Makuchal at 4:00 PM on Sunday, June 28th with 14 members and 1 guest in attendance.

Jason read the minutes from the prior meeting and they were approved as read.

The Treasurer's report was given by John Haffner and was accepted.

Old Business

Ray Carlson advised membership that the new windsock has been installed. Looks great however it only appears to read East and West wind directions.

Harry Semenko advised membership that the In Memoriam plaque will be updated within the next few weeks.

New Business

Jim's field reports for May and June:

1. We had a major problem with the Gravely mower. After getting the engine rebuilt, the left hand blade spindle froze up while mowing. It gets worse - that spindle has a double belt cast iron pulley on it for the drive belts. It took the guys three or four hours using a torch and pulley puller to get it off without causing any damage. We were being very careful because a replacement pulley (if you could find one) cost \$162.00. A new spindle cost \$210.00. So we decided to rebuild the old one using new bearings and spacers. When it was disassembled, the spindle shaft had been

worn down about three eights of an inch. If a new shaft could be found, the cost would be over \$100.00. Shye Sarig took the shaft to Diamond State Machining and had it spray welded and machined back to specs.

Although this is a very expensive process, they did it Pro Bono. The club has written them a nice thank you letter for their generosity. While we had the deck apart we decided to replace the bearings and spacers in all three spindles. Both of the spindle belts were damaged and needed to be replaced. The deck had a couple of holes, and "Caje" and Ray Bertrand repaired them by welding metal patches. We spent about \$200.00 on the repair. Both the engine and deck have been rebuilt, and the mower should give us many years of service. Thanks to all who helped with the project!

- 2. The bolts that held the muffler on the White 50" stripped. A new muffler cost \$60.00. "Caje" was able to temporarily repair it, but we will need to buy one before too long. I would like to have the Club's approval for such a major purchase.
- 3. The Club fuel is at the field for \$23.00. There are only 3 gallons left so the first person who puts the money In the Munchie Fund Can is the one who buys them.
- 4. Bill Young spread the fertilizer, and has bush hogged the areas we don't mow several times. (Continued on page 2)
